To the extent this waiver is not effective and to the extent permitted by law, I consent to any of the acts or omissions of NSW DoE or any person authorised by NSW DoE, including, without limitation, the producer and broadcaster of the Program, which would, but for this agreement, infringe any of the Participants moral rights in relation to all existing and future works and other copyright matter which arise in any way in connection with the 2018 State Dance Festival, the Program, the Recordings and Extension programs.
5. Authorise the promotion, communication and use of the Recordings and/or the Program and/or still images and/or works and other materials from the extension programs associated with the production in whole or part, in any form, manner, or medium (including via the internet) worldwide in perpetuity.
6. Acknowledge that this permission granted extends to the Participant's name, image, voice and biographical material being included in the Recordings and/or the Program and/or still images and/or works and other materials from the extension programs associated with the production and used in connection with the State Dance Festival, the Recordings and/or the Program and any use thereof in any media worldwide, including, without limitation, use by sponsors of the Schools Spectacular, the NSW DoE and any party using the Recordings and/or Programs.
