#### Task Description

The examination will consist of 3 sections. All sections are **COMPULSORY**.

- **SECTION I** – 20 multiple choice questions –
  - 15 from the **Crime** topic and 5 from the **Human Rights** topic (20 marks)
- **SECTION II** –
  - Part A – **Human Rights** - Short answer questions (15 marks)
  - Part B – **Crime** - One extended response question (15 marks) (800 words approx.)
- **SECTION III – Options** –
  - Answer **ONLY** one of the two alternatives for **FAMILY** (25 marks) in the form of an essay (1000 words approx.) **AND**
  - Answer **ONLY** one of the two alternatives for **SHELTER** (25 marks) in the form of an essay (1000 words approx.)

### What Areas of Learning will this Assessment Task Report On?

In this Trial Examination students will be assessed on their ability to demonstrate an understanding of the concepts associated with **Topic 1 Crime, Topic 2 Human Rights and the TWO Options Family and Shelter**. Students will be required to apply their knowledge of the syllabus, while also demonstrating essay writing skills.

This task will draw together the above outcomes to provide students the opportunity to demonstrate their knowledge of concepts within the study of Legal Studies. This task will allow them to gain feedback on areas of strength and areas on which to improve for their HSC. The structure and questioning style of this exam is modelled off the HSC Legal Studies Examination.
